3. In order to qualify for the 10 Year Term Committed Rate, an Acreage Dedication Shipper must have entered into a GSA with Carrier, with such GSA having a minimum term of 10 years following the In-Service Date.
4. The Uncommitted Rate shall apply to any Shipper shipping from the indicated Receipt Point to the indicated Delivery Point that does not qualify for the 10 Year Term Committed Rate.
